## Introduction

Nagar Palika Parishad Banda, invites online Tender for Solid Waste Management in 31 Wards of Banda, city under the jurisdiction of Nagar Palika Parishad Banda, U.P. on "PPP" Model

Door to Door collection, Segregation at source, Transportation of collected Municipal Solid Waste, operation of Dry MRF for quality enhancement to recover recyclables and disposal of recyclables and RDF, in accordance of Solid Waste Management Rules-2016, disposal of wet waste, mixed waste and inert at designated dumpsite at Village-Hateti Purva, Banda.

## Work description:

Collection, Transportation and Operation of Solid Waste Management facilities:

Door to Door waste collection, segregation, transportation and processing of wet waste. Operation of Material Recovery Facilities (MRF), to segregate the dry waste for its value addition and disposal of segregated waste to recycler/ waste to energy. Inert from MRF and unsegregated waste has to be disposed at existing waste dump site located at Village- Hateti Purva, Banda. Door to Door collection and Operation of MRF for management of dry waste work allotted for one + two years (subject to review after one year).

**Selection Methodology:**

1. Public opening & evaluation of the Financial Proposals: Financial proposals of only those firms who are technically qualified shall be opened publicly on the date & time specified the bid, in the presence of the Bidders' representatives who choose to attend. The name of the Bidders, their technical score (if required) and their financial proposal shall be read aloud.
2. The Financial Proposals would be ranked in ascending order of the Proposed Tipping Fee, with the Bidder quoting the lowest Proposed Tipping Fee being ranked first and the Bidder quoting the second lowest Proposed Tipping Fee ranked as second and so on.
3. In case when two or more bidders submit same lowest amount in the financial bid, those bidders are required to submit fresh financials quote in sealed envelope. The lowest quoted bidder shall be awarded the work. The new lowest financial quote must be less than the previous financial quote submitted by the bidder. Tipping fee is the amount that will be paid by Nagar Palika to the Bidder.

**Terms:**

2. The Contractor will undertake, Door-to-Door collection/ Segregation at source and transportation of MSW generated in all residential, educational, commercial and institutional area of Banda Nagar Palika, operation of MRF/ Processing facilities at Hatetipurwa Npp Banda and process the waste as per norms and directions given in solid waste management rules-2016.
3. Nagar Palika will hand over sufficient number of vehicles to Contractor, for Door to Door waste collection and waste generated from road sweeping, all vehicles are in good and working condition.
4. Collection of street waste swept and deposited at collection points by the municipal workers, Contractor will collect and transport to the dumping/ processing site and dispose as directed by the administration of Nagar Palika Banda.
5. Contractor will collect user charges from the House hold, Commercial, Institutions, Markets, Hotel and Restaurants according to the list of charges fixed and provided by the Nagar Palika Parishad Banda and deposit in Nagar Panchayat.
6. Contractor will be collect minimum 50 % of user charges in first year, if contractor failed to achieve collection target, the 50% of difference shall be deduct from tipping charges. If contractor
7. Contractor will bear all cost of fuel, vehicle maintenance including breakdowns, deploying manpower required for collection, transportation, operating and managing the MRF/ and disposal of inert/wet waste at designated dumping site.

8. The Contractor plan, organize and run a sustained awareness campaign over the Agreement Period for creating community awareness related to MSW, ensuring its mobilization and soliciting its participation/ cooperation in effective management of the solid waste.
9. The Contractor will segregate and process and dispose dry waste as per the SWM Rules 2016.
10. Contractor will issue proper I. Card, dress and safety tools to all the workers during waste collection, transportation and processing of waste.
11. The Contractor may use the Windrow composting/ vermin composting as suitable in the local conditions for the processing of Bio Degradable Waste.
12. The Contractor will segregate & process the Dry Waste, Recyclable & Combustible items from the waste and will be dispose in due time, in accordance of Solid Waste Management Rules-2016.
13. Contactor will arrange bio-culture and other necessary ingredients and apply on wet waste during the process of waste from own cost.
14. Contractor will deploy sufficient manpower tools for workers in the activity of collection, transportation, segregation and processing of waste from own cost and dispose the end products from own resources and cost.
15. Contractor will handover segregated C&D waste to Nagar Palika, free of cost for own uses of Nagar Palika.
16. The Contractor will borne Operation and Maintenance charges for all the activities including cost of fuel, used electricity, repair maintenance, Manpower expenses & all necessary ingredients like Bio-Culture, preservative etc.
17. The contractor will be responsible for repair and maintenance of vehicles, plant and machinery, during the contract period and will handover to Nagar Palika in good working condition after completion of contract period.
18. Nagar Palika shall be responsible for providing Civil and Mechanical infrastructure to process the wet waste as mutually agreed between Nagar Palika and Contractor after selection process.
19. Electric charges used at MRF for quality enhancement/ processing of dry waste shall be borne by the contractor.
20. The Contractor will be responsible for the disposal of segregated dry waste/manure within due time.
21. The contract period will be One+ Two years, if Nagar Palika satisfied with the performance of the contractor the same can be extended for further one or two years.
22. The Contractor will conduct activities only related to Solid Waste Management on the allotted premises/ site, No any other activity can be made on allowed premises/land by the contractor.
23. The contractor will submit an action plan before Nagar Palika administration for the processing of waste and start the work after its approval.
24. Contractor shall not put up any structure whether permanent or temporary without due approval of the Nagar Palika administration.
25. The contractor should obtain all required NOC from the concern authorities before commencement of the work.

26. Nagar Palika will provide requisite support to contractor for obtaining NOC, Registrations and Licenses required for the processing of waste and marketing of end products.
27. Safety guidelines to labours should be adopted as per prescribed laws and order in regard to this and there. The employees / workers of the developer so appointed by it shall not regard as employees of the Nagar Palika, they shall have any claim at all against the Nagar Palika at any stage.
28. The developer shall provide adequate insurance cover for the entire contract period for the plant machinery and all the events, which are due to his risk.
29. The Contractor will provide technical assistance to Nagar Palika Administration in conducting IEC activities to create public awareness.
30. Contractor will keep proper records of waste processing and produced manure or recyclables and will be produce before Nagar Palika on Monthly/Quarterly/ basis as directed by Nagar Palika.
31. Developer will be responsible for maintaining hygiene and cleanness at the MRF and waste processing site.
32. The payment of tipping charges will be made on monthly basis, Contractor will produce the Bill (as finalize through bidding process) before Nagar Palika in two copies. Nagar Palika will process the Contractors Bill and release the payment within 15 days (subject to availability of funds).
33. The amount generated from the royalty of end products will be used for IEC activities to create public awareness within Nagar Palika area, but its utilization plan should be approved by the Nagar Palika administration.
34. Contractor will hand over all the vehicles, assets like plant and machinery, tools etc. to Nagar Palika in good and running condition after completion of contract period.
35. The Contractor's worker (Safai Karmchhari) will not perform any private work during the working hours. If any worker found doing private job/work during the working hour's then contractor will be fined for Rs. 500.00 (amount) per day per worker.
36. In case of workers strike last for more than a day then agency will be fined for Rs. 10000.00(Ten Thousand) per day. If agency worker don't perform their duty continuously for 10 days then Nagar Palika Parishad Banda, has the right to seize the performance security and right to cancel the agreement.

**Note:- The selected firm will have to carry out the operation of door to door waste Segregation, Collection and MRF by entering into a separate contract with the consent of both the other urban parties of the district subject to the above rules and regulations as per the directions given by the District Magistrate.**
